said. "He got me from work and that, scared me right there. He didn't threaten me, but he said I could be thrown in jail if I didn't tell the truth."

Later, he said things were straightened out and he told Meyer the three had been at his house only once.

The testimony of Frazier's wife, Sandy, was similar to her husband's Friday.

She said she was home when the man and two children came there and she let them in, but she doesn't remember why.

She said she had never seen him or the children before and that the man and girls were there 30 minutes to an hour. Nor did she recall if she talked to the man or what he might have said.

But she testified she was "positive" the children and the man were Brandi, Tiffani and Roy Summers, based on the pictures officers showed her.

Like her husband, she first told Meyer the children were at her house two or three times, because he told her other people had said so and she was afraid not to agree because she thought she might be jailed.

She admitted Friday that she had lied about that, and also that she had lied when she told Meyer the man who had come with the children was a friend.

"Today is the first day I've said I've seen them only one time," she added.

In addition to the others, Casner's brother, Robert James Casner, began testifying Friday.

He lives in Cedar Ridge where Lee and several other members of his family dwell.

He testified he had lived in Nampa from April or May of 1976 to April of 1977, and had visited Lee and his wife, Molly, when they lived there in 1978.

They had gotten together then to discuss plans for all of them to move to Grass Valley, which they subsequently did.

After staying in Grass Valley about six months, Lee and Molly left for Nampa again, his brother testified Friday. But Lee returned to northern California in "the spring or early summer" last year. Molly stayed in Nampa until this January when she joined her husband in Cedar Ridge.

When Canty showed Robert Casner a picture of Roy Summers Friday, he said the man's face was "vaguely familiar," but that he couldn't associate the face with the name "Summers."

Casner's testimony was cut short because court was adjourned, but he will continue testifying Monday at 10 a.m. when the hearing resumes.

Man critical after fight

ADELANTO — An 18-year-old El Mirage man was in critical condition at San Bernardino County Medical Center Friday evening after being shot in a fight near here, San Bernardino County sheriff's deputies said.

James Jensen Jr. was shot in the face when a .22-caliber rifle accidentally discharged Friday afternoon in a fight at El Mirage which involved him, his father, James Jensen Sr., and several other people, deputies said.

The father was later taken to Victor Valley Community Hospital after suffering a heart attack. No arrests were made pending further investigation, deputies said. Deputies said Jensen and his father went to a mobile home and began arguing with the common-law husband of the victim's sister.

A .22-caliber rifle accidentally discharged in the fight and the bullet struck the younger Jensen, deputies said.
