mers in Oregon, said Friday afternoon that he had not heard about Summers' desire for extradition.

"I plan to take all my shots at Mr. Summers first unless he wants to make some sort of a deal." Harvey said in a telephone interview

Harvey said he has discussed a possible plea bargain with Summers' attorney, but did not know if Summers would agree to it. Summers is scheduled to face three separate trials on the Oregon charges, the first of which will begin Jan. 14. The second is scheduled for Jan. 22 and the third Feb. 7. Harvey said.

Mike Dugan, chief deputy district attorney in Deschutes County, said, "We've got him and we're going to keep him. It's the economics. We'd have to pay to bring him back to Oregon after he went to California.

He said San Bernardino police have raised no objection to allowing Oregon to complete its prosecution before Summers is released to California

In a phone call to The Sun. Summers' mother said Friday that her son told her he did not kill Wise or take the children and that he is willing to take polygraph tests and undergo hypnosis to prove it.

'He has an iron-clad alibi. He was in Utah when it happened." Herman said.

She said Carino was not involved either and the charges against Summers were "trumped up.

This has been simply terrible for us. It's expensive in a million ways and there is no guilt involved here - none," she said.

Herman said she believes publicity about Summers' desire to face the San Bernardino charges "can only help us. That's our feeling anyway

She also said that although her son cut her with a knife on the hand and upper body while she was with him in Oregon earlier this year, that happened only because she was trying to protect him from himself.

"He was drinking and he had said he was going to try to kill himself. I was trying to protect him from himself and I came in contact with a knife." Herman said.

During that incident, Summers told his mother that he wanted to leave behind a tape-recorded testimony about what he had endured during the four years he was in Vacaville state prison, Herman said. He was in prison there on a rape charge, she said.

## U.S. raps Moscov

atives from other countries there also.

In an apparent signal to other Moslem countries, Carter pointedly noted that Afghanistan is an overwhelmingly Islamic country.

'This is the first such venture in a Moslem country since the Soviet occupation of Iranian Azerbaijan in the 1940s," he said.

The reference was to a northern province of Iran which was occupied by Soviet forces until 1946 despite a Soviet promise to withdraw at the conclusion of World War II. The Soviets finally

withdrew under heavy diplomatic pressure from the United States and other countries.

In his earlier statement, State Department spokesman Thomas Reston said the United States would file a formal protest with the Soviets over actions in the Afghanistan coup that installed a pro-Soviet leader.

He said the United States has received information that Soviet troops, using armored personnel carriers, were directly involved in fighting at the headquarters of Radio Afghanistan on Thursday.

Reston added that Soviet planes were spotted over Kabul, the Af-
