Ex-Nazi nabbed on sex charge

CHICAGO (AP) — The new chief of the National Socialist Party of America said Friday the group supplied information that led to the arrest of former leader Frank Collin on charges of sexually abusing children.

"Quite frankly, we handed Frank Collin to the cops on a silver platter," said Harold A. Covington, former deputy leader of the neo-Nazi group. He said party members discoverd Collin's activities last November and informed police. Collin was expelled from the party Nov. 21, Covington said.

Covington said "films, pictures and names and addresses of some of the boys" were found in the party's headquarters.

Collin, 35, was arrested Thursday following police investigation of the allegations.

Police said he is accused of taking indecent liberties with boys ranging in age from 10 to 14. Bond was set at \$50,000.

Police said the boys were solicited in Chicago's northern New Town neighborhood and taken to the party's headquarters on the South Side.

Collin had sex with the boys and then took nude pictures of them, police said.

"The boys . . . told us they did not realize he was a Nazi leader and thought the swastika hanging in his bedroom was some sort of Chinese design," said investigator Ed Carmody said.

Collin, whose plans to march in suburban Skokie outraged Jewish residents in 1978 and touched off a major First Amendment debate, was ousted as leader by party members who said he was "burned out" and no longer operating efficiently.

face charges in California first because he believed he wouldn't receive a fair trial in Oregon "with the awful charges in California hanging over my head" and because of newspaper publicity in Oregon of the charges there.

He faces three trials in Bend in connection with the attempted murder, assault and kidnapping of his present wife, Connie, and the assault and kidnapping of his mother, Loucylle Herman. The first trial will begin Monday.

Mosgrove had said this week that he didn't think "the rather minor amount of newspaper publicity in The Bulletin (a local publication) would hurt his ability to get a fair trial here," as Emerson had contended.

Oliver said Friday that Atiyeh agreed with that reasoning.

"Besides, Summers is obviously getting publicity in San Bernardino and he'd face the same problem there," Oliver said. "So they seem to cancel each other out."

Emerson said Friday he was "disappointed" by the decision, but "now we'll give the trials (here) our best shot."

Summers' sister, Karen Carino of Springfield, Va., is charged with accessory to both murder and kidnapping.

Her extradition hearing is scheduled for Feb. 14 in Richmond, Va., which would be 90 days after her arrest last November, the limit for an extradition to take place.

Extraditions are done through state governors' offices which act on information received from law enforcement agencies.

Despite the fact that there is only about one month left to get Carino here, San Bernardino County Chief Deputy District Attorney Joseph Canty, who is handling the case, has not yet sent the information to California Gov. Brown, who in turn must send it to Virginia Gov. John Dalton.

Canty said Friday he couldn't comment on why he hadn't sent in the information, but said "we're processing the case according to the requirements of law. It is still our intention to extradite her to California. The details of where it's at and why, I can't comment on."

Joanne Richardson, who helps handle extraditions in Gov. Brown's office, said Friday that processing and reviewing an extradition case usually takes 10 to 14 days.

Police belive that a few months after the children were abducted, they visited Carino's home in Pleasanton, Calif., where she then lived.
